Proposed revisions to the PRLRC Constitution and By Laws
The PRLRC Board has recommended the followed revisions to the club's Constitution and By Laws.
Revisions are underlined.

The following changes will be voted on @ the November 14 meeting.
The Complete Bylaws are available on the Club website.

Bylaws

Article I - Membership

Membership Application Change:

All New membership applicants will be accepted as Provisional Members for 1 year under a new ruling proposed by the Board of Directors. If voted in, this change will take effect on November first which is the start of the new club year. Any membership applications that have already been received and read at the last meeting will be accepted on the old policy.

Article I - Membership

Section 1. Eligibility. Membership shall be open to all persons 18 years of age and older who are in good standing with The American Kennel Club and who subscribe to the purposes of this club. The club's primary purpose is to be representative of the breeders and exhibitors in its immediate area. Persons residing in states other than Connecticut or Rhode Island are eligible for Associate Membership. Associate members are entitled to all club privileges except voting and office holding and as such do not affect quorum for meetings.

Section 2. Dues. Membership dues shall be established on an annual basis as approved by the Board of Directors, payable on or before the 1st day of November of each year. New members joining after September 1st will be considered paid through the following year. No member may vote whose dues are not paid for the current year. During the month of September the Treasurer shall send to each member a statement of dues for the ensuing year.

Applicants for membership who have been rejected by the club may not reapply within six months after such rejection.

Section 4. Termination of Membership. Memberships may be terminated:

(a) *by resignation.* Any member in good standing may resign from the club upon written notice to the Secretary; but no member may resign when in debt to the club. Dues obligations are considered a debt to the club and they are incurred on the first day of each fiscal year.

(b) *by lapsing.* A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid 90 days after the first day of the fiscal year; however, the board may grant an additional 90 days of grace to such delinquent members in meritorious cases. In no case may a person be entitled to vote at any club meeting whose dues are unpaid as of the date of that meeting.

(c) *by expulsion.* A membership may be terminated by expulsion as provided in Article VI of these bylaws.

Article I - Membership

Section 2. Dues. Membership dues shall be established on an annual basis as approved by the Board of Directors, payable on or before the 1st day of November of each year. New members joining after September 1st will be considered paid through the following year. No member may vote whose dues are not paid for the current year. During the month of September the Treasurer shall send to each member a statement of dues for the ensuing year.

Section 3. Election to Membership. Each applicant for membership shall apply on a form as approved by the board of directors and which shall provide that the applicant agrees to abide by the constitution and bylaws and the rules of The American Kennel Club. The application shall state the name, address, occupation, and type of membership desired (full or associate.) The application shall carry the endorsement of two members in good standing. A \$25.00 application fee must be submitted with the application form. All new applicants will be designed a Provisional member for one (1) year.

All applications are to be filed with the Membership Chair and each application is to be read at the first meeting of the club following its receipt. At the next club meeting the second reading of the application shall occur. Applications will be held for one (1) year from the date of receipt. During this year, applicants will be required to attend a minimum of two (2) meetings or two (2) club events or combination of. Upon completion of the 1-year Provisional Membership, the application will be voted on for either Full or Associate status. For both Full and Associate membership, affirmative votes of 2/3 of the members present and voting by secret ballot at that meeting shall be required to elect the applicant. Applicants for membership who have been rejected by the club may not reapply within six months after such rejection.

Section 4. Termination of Membership. Memberships may be terminated:

(a) *by resignation.* Any member in good standing may resign from the club upon written notice to the Secretary; but no member may resign when in debt to the club. Dues obligations are considered a debt to the club and they are incurred on the first day of each fiscal year.

(b) *by lapsing.* A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid 90 days after the first day of the fiscal year; however, the board may grant an additional 90 days of grace to such delinquent members in meritorious cases. In no case may a person be entitled to vote at any club meeting whose dues are unpaid as of the date of that meeting.

(c) *by expulsion.* A membership may be terminated by expulsion as provided in Article VI of these bylaws.

Section 5. Membership Requirements. All members are encouraged to work at least two club events per years. All Full Members are required to attend two (2) regular monthly meetings and work at least two (2) club events per year.

Article II - Meetings and Voting

Section 1. Club Meetings. Meetings of the club should be held each month in the greater Pawcatuck River area at such hour and place as may be designated by the board of directors. Written (or electronic) notice of each such meeting shall be mailed by the Secretary at least 10 days prior to the date of the meeting. The option to receive written or electronic notice of meetings and newsletters will be given to members. Members should inform the club secretary of their preference. The club newsletter may serve as written notice to announce a monthly meeting at the times when it is published. Newsletter publishing schedule will be posted on the club web site. The quorum for such meetings shall be 20 percent of the members in good standing.

Section 2. Special Club Meetings. Special club meetings may be called by the President, or by a majority vote of the members of the board who are present and voting at any regular or special meeting of the board; and shall be called by the Secretary upon receipt of a petition signed by five members of the club who are in good standing. Such special meetings shall be held in the greater Pawcatuck River area at such place, date, and hour as may be designated by the person or persons authorized herein to call such meetings.

Section 3. Board Meetings. Meetings of the board of directors should be held at least 6 times a year in the greater Pawcatuck River area at such hour and place as may be designated by the board. Written (or electronic) notice of such meeting shall be given by the Secretary at least five days prior to the date of the meeting. The quorum for such a meeting shall be a majority of the board.

Section 4. Special Board Meetings. Special meetings of the board may be called by the President; and shall be called by the Secretary upon receipt of a written request signed by at least three members of the board. Such special meetings shall be held within the greater Pawcatuck River area at such place, date, and hour as may be designated by the person authorized herein to call such meeting. Written notice of such meeting shall be mailed by the Secretary at least five days and not more than 10 days prior to the date of the meeting. Any such notice shall state the purpose of the meeting and no other business shall be transacted thereat. The quorum for such a meeting shall be a majority of the board.

Article III- Directors and Officers

Article III - Directors and Officers

Section 1. Board of Directors. The board shall be comprised of the officers and two directors, all of whom shall be members in good standing and all of whom shall be elected for one-year terms at the club's annual meeting as provided in Article IV and shall serve until their successors are elected. General management of the club's affairs shall be entrusted to the board of directors.

(a) Officers and board members may not be officers or board members of another Labrador Retriever specialty club within the New England regional area.

Section 2. Officers. The club's officers, consisting of the President, Vice President, Recording Secretary, Corresponding Secretary, and Treasurer, shall serve in their respective capacities both with regard to the club and its meetings and the board and its meetings.

(a) The President shall preside at all meetings of the club and of the board, and shall have the duties and powers normally appurtenant to the office of President in addition to those particularly specified in these bylaws.

(b) The Vice President shall have the duties and exercise the powers of the President in case of the President's death, absence or incapacity.

(c) The Recording Secretary shall keep a record of all meetings of the club and of the board and of all matters of which a record shall be ordered by the club.

(d) The Corresponding Secretary shall have charge of the correspondence, notify members of meetings, notify new members of their election to membership, notify officers and directors of their election to office, keep a roll of the members of the club with their addresses, and carry out such other duties as are prescribed in these bylaws.

(e) The Treasurer shall collect and receive all moneys due or belonging to the club. Moneys shall be deposited in a bank designated by the board, in the name of the club. The books shall at all times be open to inspection by the board and a report shall be given at every meeting of the condition of the club's finances and every item of receipt or payment not before reported; and at the annual meeting an accounting shall be rendered of all moneys received and expended during the previous fiscal year. The Treasurer shall provide the President a copy of the monthly Treasurer's Report. The Treasurer shall be bonded in such amount as the board of directors shall determine.

Section 3. Vacancies. Any vacancies occurring on the board or among the offices during the year shall be filled until the next annual election by a majority vote of all the then members of the board at its first regular meeting following the creation of such vacancy, or at a special board meeting called for that purpose; except that a vacancy in the office of President shall be filled automatically by the Vice President and the resulting vacancy in the office of Vice President shall be filled by the board.

Section 4. Confidentiality. Officers and Directors of the Board will not disclose the confidential information discussed within the club's board meetings until such time as the membership is informed of any proposal or topics discussed or decided upon during those meetings.

Article V- Committees

Article V - Committees

Section 1. The board may each year appoint standing committees to advance the work of the club in such matters as specialty shows, obedience trials, field trials, trophies, annual prizes, membership and other fields which may well be served by committees. Committee guidelines may be found on the club web site. Such committees shall always be subject to the final authority of the board. Committee Chairs (or in their absence, a committee member) should be prepared to present a report to the board of directors on request. Committee report meetings may be held at such hour or place convenient to committee chair and board of directors. Special committees may also be appointed by the board to aid it on particular projects.

Section 2. The board may appoint an ad hoc Auditing Committee as necessary for the purpose of auditing the Treasurer's accounting book.

Section 3. Any committee appointment may be terminated by a majority vote of the full membership of the board upon written notice to the appointee; and the board may appoint successors to those persons whose services have been terminated.

Section 4: Committees will not disclose the confidential information discussed within a committee meetings without permission from the board of directors.
